I. ORTHOPAEDIC PHYSICAL THERAPY PRACTICE

A. Advertising

Due to the potential for unethical and possible illegal aspects of physician owned physical therapy services, *OP* will not knowingly publish advertisements in the classified ads for solicitation of therapists for such organizations, nor will they knowingly publish any other advertisements for physician owned physical therapy facilities.

B. Editing

The contents of *Orthopaedic Physical Therapy Practice* are structured to best serve the needs and interests of the Section membership. *OP* is edited for the members of the Orthopaedic Section. Publishing and editorial decisions are based on the Editor's judgment of the quality of writing, the timeliness of the article, and the potential interest to the readers of *OP*. The Editor reserves the right to edit manuscripts as necessary for publication.

C. Publication Content

From time to time *OP* might publish editorials or articles dealing with controversial issues. The views expressed in *OP* are those of the authors and may not reflect the official policy of *OP*, the Orthopaedic Section, or the American Physical Therapy Association. No endorsement of those views should be inferred unless specifically identified as the official policy.

D. Reprint Requests

Will be granted without charge for educational purposes. For profit situations will be charged at the rate of \$100 per article. If the request is for printed material, direct expenses plus 15% will be charged.

E. Copyright

Copyright is retained by the Orthopaedic Section, APTA, Inc. and all requests for reprints will include a reprint statement indicating the copyright holder as the Orthopaedic Section, APTA, Inc.

II. CONTRACTED JOURNALS/NEWSLETTERS

A. Contract Renewal

- i. A 15% up charge will be added to the direct billing expense for printing, postage, and mail service.
- ii. The management fee will be billed at \$75 per hour based on the contracted number of pages per issue.
- iii. The annual cost of living increase will be 5% for printing, postage and mail service.
