### **Update on Committee Activities since CSM 2010:**

An initial draft of a "minimal data set" modeled after the Neck Pain clinical practice guidelines was created at the Orthopaedic Section/APTA Database Meeting in October 2010.

Joe was invited to present the Orthopaedic Section's clinical practice development methods and strategic plan at the APTA's Department of Practice, "Development of Evidence-Based Documents and GRADE Methodology Workshop" meeting in November 2010. The other invited participants at this meeting were potential clinical practice guideline leaders of the Pediatric, Neurology, Oncology, Cardiopulmonary, and Geriatrics Sections. Christine McDonough, PT, PhD, was the other Orthopaedic Section member who participated in this meeting.

A position for a "National Guidelines Clearinghouse Coordinator" was created in 2010. The primary role of this individual is to submit and follow the acceptance of each of our clinical practice guidelines to the AHRQ's National Guideline Clearinghouse following the procedures provided on the [www.guidelines.gov](http://www.guidelines.gov) Web site. JW Matheson was appointed to this position for a 3-year term.
