 - 4.1. Education Planning Task Force John Lowe and Doug Flint
 - 4.1.1. The pre-conference course has been outlined.
 - 4.1.2. John and Doug need suggestions for faculty for this course by October 1, 2014. The proposal will be placed in Scholar One in December, 2014 for programming in 2016.

 - 4.3.1. The grant application has been accepted by APTA. This provides \$10,000 to develop the Worker Rehabilitation Clinical Practice Guideline. The OHSIG has agreed to fund \$20,000 for the CPG sponsored by the Orthopaedic Section. Reuben Escorpizo is leading the development.
 - 4.3.2.The Occupational Health Physical Therapy "guidelines" that were rescinded by APTA are now available on the OHSIG page in the Orthopaedic Section website. The documents do not meet the criteria for Clinical Practice Guidelines which are determined by the national guideline clearing house. These works are referenced by educators and outline fundamental components of occupational health Physical Therapy. This information is in need of revision including updates and the addition of ergonomics. The question arises how these documents can be update and appropriately offered as a reference to members. Pam Duffy will advise the OHSIG.
