PT's who are affiliated with universities often have access to full-text e-journals or interlibrary requests. Many articles are available on-line through their respective publishers. Others are available through the free medical journals site (www.FreeMedicalJournals.com). If none of these methods are successful, at the very least, you can obtain the abstracts by downloading the EndNotes libraries we've posted on our webpage and clicking on the individual citation or by logging onto http://www.pubmed.com to see if the articles are worthy of purchase.
