

In this time of hustle and bustle it is important to look back and recap the highlights. It is easy to lose sight of all we have accomplished when we are only focused on what more needs to be done. The ORF-SIG has had a number of wins this past year which I would like to highlight.

Combined Sections Meeting:

- We completed another great pre-conference session, "Creating and Maintaining Competitive Residency and Fellowship Programs" and expanded beyond just residency/fellowship development to cover ways to be more efficient and share resources and concrete ways to improve our overall post graduate training. This day long meeting inspired many of the initiatives that we are working on to improve efficiency and collaboration between programs. Please join us for CSM 2024 for another collaborative pre-conference day.
- We also presented an ORFSIG leadership education session titled, *Mentoring Smarter not Harder*. This program had a huge turnout and tackled ideas for mentoring to improve efficiency to truly assess clinical reasoning of our residents. This was the first time the ORF-SIG presented an education session at CSM, and we had another session accepted for 2024!

Research:

- We had our first IRB accepted and we have collected from over 80 graduates regarding their residency training. See below for ways to expand the data collection to your graduates as well!
- Over 100 current Orthopaedic residents submitted their case studies and research projects to the inaugural platform presentation for CSM 2024! See below for specifics.

Collaboration of Didactic resources:

• We compiled a team to start sharing OCS style test questions to build a question bank for all ORF-SIG programs to use and implement as needed with our residency/fellowship programs. Research and Publication Opportunities Universal Graduate Survey

Residency and fellowship programs for physical therapists develop expertise in specialty and subspecialty fields of physical therapy to serve our patients' needs better. Over the past 3 decades, residency and fellowship programs have grown dramatically. Residency and fellowship programs are required to survey their graduates to determine program outcomes, but the data produced from these surveys have always been individualized to each program. Thus, there needs to be more peer-reviewed information on the outcomes of residencies and fellowships. Members of the ORF-SIG consolidated their program's surveys into a single survey and recently obtained IRB approval to distribute to any member programs who are interested in participating. The results of this survey will help member programs improve recruitment and curricular development. Please share this QR code with all of your graduates and ask them to complete it. Applicant Registry:

Steve Kareha, Molly Malloy, Kirk Bentzen, Carrie Schwoerer One big problem facing programs over the years is the ability to sustain consistent applicant bases despite using or not using RF-PTCAS. Our team had been working hard to collect interested applicants to attempt to steer them to open positions. We are brainstorming to revise this system to tackle the problem from the front end focusing on the following:

- 1. Raise awareness for our programs,
- 2. Steer qualified applicants to our programs, and
- 3. Address the problems of open positions throughout the country.

In the meantime, you can continue to use this link for an excess of applicants who you are open to sharing of their information. Specifically, for those qualified applicants who are excellent candidates and have already been vetted but applied to a program that does not have any available spots. The program denying admission may then provide the applicant with a flyer explaining the database and providing them the option to participate. What is the Program Spotlight?

It is an ORF-SIG, member-only feature that allows one or more orthopaedic residency/fellowship programs to be Spotlighted within a given month to market themselves to prospective candidates and those seeking more information on post professional education in orthopaedics. Additionally, programs will also be spotlighting individual faculty and/or residents/fellows-in-training as good-will ambassadors of their respective programs.

What are the benefits to being Spotlighted?

Programs that are Spotlighted advance the exposure and interest in post professional orthopaedic physical therapy programs across the country, thus bolstering their program's sustainability. Furthermore, by providing important, decision-making details about their program a prospective candidate can make a better-informed decision about which program may be a good fit for them.

Who is eligible to apply?

Program coordinators or Program directors may apply for their program as long as they meet the following pre-application criteria:

- The program must be ABPTRFE or ACOMPTE accredited or in Candidate status.
- The Program Director or Coordinator must be a member of the AOPT and ORF-SIG.
- The Program Director or Coordinator must have a specialization in Orthopaedics.

On December 1, 2023, the canine sporting and physical therapy world lost a legend. Janet Steiss, the first DVM, PT, was a staple figure in the field with hunting dogs. She identified and described 'limber tail' in the hunting dog in 1999. In 2002, she published a canine injury survey - a list of the most common orthopedic injuries commonly seen in sporting, working, and herding dogs from 1990-2001. She was active in the American Canine Sports Medicine Association (ACSMA) and published a survey of ACSMA members' representation of their time involved with "sporting and working dogs, and the popularity of the various canine sports". Her contributions were tremendous. She had the knowledge, clinical skills, and clinical reasoning from the perspective of the veterinarian and physical therapist, all of which are required in the field of canine rehabilitation. We will miss her unique contribution to canine rehabilitation, as well as her friendship.
